## 1. APPLICATION FOR TELECOMMUNICATION TOWER 1151 RINGWELL DRIVE – WARD 3 (NORTH OF DAVIS DRIVE, EAST OF LESLIE STREET) OUR FILE NO.: D11-NP1506 MALGORZATA MIESOWICZ (ROGERS COMMUNICATIONS INC.)

Application for Telecommunications Facility to permit a new 40 metre monopole tower to be erected on the subject lands.

Cathy Bilotta, Director, Projects and Administration of Standard Land Company Inc. was present to address the Committee.

A resident addressed Committee and expressed concerns with the proposed tower.

The Site Plan Review Committee recommends:

- 1. Application for Telecommunications Facility to permit a new 40 metre monopole tower to be erected on the subject lands be approved in principle and referred to staff for processing, subject to the following:
  - a. THAT the preliminary review comments provided to the applicant be addressed to the satisfaction of Town Staff;
  - b. THAT Committee request the applicant provide a donation in the amount of \$10,000.00 to the Town for a community benefit.
- 2. AND THAT Cathy Bilotta of Standard Land Company Inc., Suite 600, 366 Bay Street, TORONTO, ON M5H 4B2, be notified of this decision.
- 2. APPLICATION FOR AMENDMENT TO SITE PLAN APPROVAL 18106 AND 18110 YONGE STREET – WARD 7 (NORTH OF DAVIS DRIVE, WEST SIDE OF YONGE STREET) OUR FILE NO.: D11-NP1508 THE REGIONAL MUNICIPALITY OF YORK

Application for Amendment to Site Plan Approval to permit an addition having a gross floor area of 3,310 m<sup>2</sup> to the existing bus storage facility and a new Emergency Medical Services facility having a gross floor area of 555 m<sup>2</sup> together with a parking lot expansion on the subject lands.

- 3. AND THAT Lauren Capilongo, Associate of Malone Given Parsons Ltd., 140 Renfrew Drive, Suite 201, MARKHAM, ON L3R 6B3, be notified of this decision.
