- We are active participants in the development and implementation of active transportation master plans.












### Schedule A: Newmarket East-West Bikeway - OMCIP Project

AND WHEREAS Council now indicates, by a resolution dated no earlier than June 10, 2015, Council's continued support for the construction and operation of the Projects anywhere in the Local Municipality (the "New Resolution");

AND WHEREAS, pursuant to the FIT Contract, where a New Resolution is received in respect of the Projects in the Local Municipality, Suppliers will be recognized as fulfilling the requirements under Section 2.4(d)(vii) of the FIT Contract, which may result in Suppliers being offered Notice to Proceed in accordance with the terms of their respective FIT Contract(s);

NOW THEREFORE BE IT RESOLVED THAT:

Council of the Town of Newmarket supports the construction and operation of the Projects anywhere in the Town of Newmarket.

This resolution's sole purpose is to enable Suppliers to achieve Notice to Proceed under their FIT Contracts and may not be used for the purpose of any other form of municipal approval in relation to a FIT Contract or Project or for any other purpose.

This resolution shall expire twelve (12) months after its adoption by Council.


THEREFORE BE IT ENACTED by the Municipal Council of the Corporation of the Town of Newmarket as follows:

BY-LAW NUMBER 2015-53

A BY-LAW TO CONFIRM THE PROCEEDINGS OF A MEETING OF COUNCIL - NOVEMBER 16, 2015.

- 3. AND THAT nothing in this by-law has the effect of giving to any decision or resolution the status of a by-law where any legal prerequisite to the enactment of a specific by-law has not been satisfied;
- 4. AND THAT any member of Council who disclosed a pecuniary interest at the meeting at which this by-law is passed shall be deemed to have disclosed that interest in this confirmatory by-law as it relates to the item in which the pecuniary interest was disclosed.

# Newmarket Arenas

- 16% of our ice surfaces are in a single surface facility
- Less than 20% of our arenas are more than 30 years old
- Our ice surfaces are utilized 85% during prime time.

# **Toronto Arenas**

- 82% of Toronto's arenas have only one ice surface
- Only 6% (3 of the 49 arenas) are newer than Hollingsworth.
- In fact, 23 Toronto arenas were built prior to 1960 – almost half of their assets - are at least 55 years old and still in active use today.
- Toronto's target is 75% utilization

# What is the true cost?

- The operating costs of maintaining an ice surface is relatively the same regardless of the number of ice pads in a facility; the capital costs are greater for a single surface facility but once spent, they become a sunk cost with no ongoing exposure
- The operating costs of maintaining an arena are relatively the same – per square foot regardless the number of ice surfaces.
- Declaring Hollingsworth surplus only shifts the operating costs and adds to our capital expenditures with minimal benefit to community

# Recommendations

- Fully explore the alternative of maintaining Hollingsworth because I don't believe (and Toronto's experience seems to support this belief) it is near the end of its service life.
- Seek out opportunities to maximize the off season usage of Hollingsworth to further offset ongoing operating costs
- Continue to explore a partnership with Pickering College as we need more recreational facilities – not less – and sharing the cost is a good strategy
