 Correspondence from the Planning and Building Services Department dated October 13, 2015 regarding Notice of Complete Application, Proposed Official Plan Amendment and Zoning By-law Amendment - 260 Eagle Street.

6. Plagues

The Chair addressed the Committee regarding the Plaque Program and summarized concerns related to accountability in responding to plaque requests. Discussion ensued regarding the current plaque supplier and plaque production and proactively determining homes that would be eligible for plaques. The Senior Planner, Community Planning to work with Malcolm Watts to review options for plaques to extend their longevity and determine associated cost implications.

c) Heritage location plaques

The Chair provided updates on the proposed Heritage location plaques for the newly constructed western leg of the Tom Taylor Trail, World War Two Camp and the Rogers plaque. Discussions with Town staff are underway with respect to funding for the plaques and potential locations where each can be placed.

7. Heritage Newmarket Budget

The Council/Committee Coordinator provided a verbal update on the balance of the Heritage Newmarket account and the Heritage Fund. The Chair provided a verbal update with respect to façade improvements on Main Street, including brick restoration on the upper storey of the building at 205 Main Street.

8. Discussion regarding delegation of authority of the granting of heritage permits for designated properties.

The Senior Planner, Community Planning, provided an overview of the heritage permit approval process and advised that the authority to approve applications can not be designated to a municipal heritage committee per legislation but can however be delegated to staff and recommended that option. Discussion ensued regarding the ability for Heritage Newmarket to comment on any heritage permits and the ability to provide feedback into the process for drafting a delegation by-law for heritage permits.

9. Discussion regarding an Application for Official Plan and Zoning By-law Amendment, 260 Eagle Street, Town of Newmarket, 7113671 Ontario Corp. (Oxford Homes), File No.: D09NP1515, D14NP1515.

The Newmarket Heritage Advisory Committee recommends:

a) THAT the application for Official Plan and Zoning By-law Amendment, 260 Eagle Street be further reviewed to address the following concerns, as expressed by the Heritage Newmarket Advisory Committee:

- a) The application contravenes the Town's Official Plan and Zoning By-law documents with respect to building height allowances;
- b) The proposed structure appears to be invasive in nature to the surrounding residential community including the heritage home located at 310 Eagle Street, the Pioneer cemetery and the surrounding small post-war homes abutting the subject property;
- c) The proposed development may interfere with surrounding property owners enjoyment, as evidenced by the shadow study conducted as part of the application process.

d) Newmarket Historical Society Board of Directors

Rohit Singh provided a verbal update and advised that he has not received any correspondence to date from the Newmarket Historical Society. The Council/Committee Coordinator to follow up with the Newmarket Historical Society.

- a) The Chair provided a verbal update on the lack of stewardship of the Bogart House, with the exception of perimeter fencing to restrict access to the home. In addition, the Chair advised that it is alleged that an infant grave was located on the property, however, has been relocated to the Newmarket Cemetery.
- b) The Chair advised that the Committee's membership to Community Heritage Ontario is due to expire.

Dear Chris Ann,

Thank you confirming that the Quaker Meeting House Proposal is on the agenda for the Heritage Newmarket meeting on December 1^{st} 2015. Please confirm the time and location to which members of the Meeting House must attend.

As requested please find the following background comments and description of the proposal with drawings attached.

Representatives from the Meeting House presented to the committee approximately two years ago for information. That was a larger proposal for additional community rooms and kitchen. The version to be presented on December 1st is a more modest addition to the existing west entrance stair, to house a vestibule and accessible elevator alongside the existing stair, which is to remain. The interior is to be renovated accordingly to accommodate those new features. The basement will be renovated to accommodate an accessible washroom and public space altered to provide access to the elevator.

The form of the addition is generally, we believe, in keeping with the existing west entrance and its simple gable roof and board and batten wall finish. The new entrance vestibule is proposed in wood frame and glass to enclose the entrance but maintain a view to the existing walls and entrance. The original west wall of the Meeting House - the heritage designated part of the building - will be left largely untouched except for possible improvements required by the Ontario Building Code.


The roof will match the cedar shakes and the walls and windows will match existing. Please find two attachments. One is a sheet indicating the three elevations in water colour. The other attachment indicates two floor plans with notes as to some of the detailed improvements.








Greetings friends and colleagues,

The Ontario Historical Society would like to inform you that the Ministry of Tourism, Culture and Sport (MTCS) is pursuing the development of a Culture Strategy for Ontario. The Ministry's objective is to establish a vision for culture across the province, and they want to know which aspects of Ontario's culture are valuable to you and your community.

One of the most valuable cultural resources in Ontario is our heritage sector. All across the province, not-for-profit organizations such as historical societies, museums, archives, and other heritage organizations and institutions are working to preserve and promote our diverse history. Activities such as cemetery tours, historical walks, community bike tours, plaque unveilings, archaeological digs, and visits to museums and historic sites are just a few examples of how Ontarians participate in culture by connecting with their heritage. Many of Ontario's grassroots heritage organizations also work tirelessly to protect our natural history—which is a vital part of both our cultural

identity, and our tourism industry.

Since government funding to heritage organizations was both cut, and frozen, in the mid-1990s, the groups who provide these services to their communities have been forced to do more with less. These are the people restoring our train stations, preserving our lighthouses, defending our cemeteries, protecting our genealogical resources, and telling our stories through lectures, films, publications, and exhibitions. Despite all their valuable work preserving our historical landmarks and cultural landscapes, government funding to these not-for-profit organizations remains incredibly low.

These groups are also acting as a voice for their communities. Aboriginal history; women's history; the history of diaspora in Canada; black settlers who fled north to escape slavery; family genealogy—all of these narratives are pieces of our identity as Ontarians. We have hundreds of historical societies, museums, and other heritage institutions working to tell these stories, and many more. Help ensure that their valuable work is recognized and supported!

The deadline for public submissions to the MTCS is December 7, 2015.

Make sure that your interests, and those of your community, are accurately represented in the new Culture Strategy for Ontario.

How to get involved:

The Ministry has developed a <u>Discussion Paper</u> outlining the importance of culture within our communities, and the many different events, institutions, and industries which help us to define and express that culture. **Pages 3, 14, & 15** will be of particular importance to those with an interest in heritage activities and services. The Ministry has also provided a list of discussion questions at the end of the paper (page 16), for your consideration.

In addition to the discussion paper, the MTCS issued a press release defining the <u>Guiding Principles</u> of the Culture Strategy initiative, and announcing the members of the <u>Culture Strategy Advisory Group</u>, who will provide expert

advice to the MTCS on the Culture Strategy.

This is a unique opportunity for Ontarians across the province to have their voices heard. The Ministry is offering a few different ways for you to participate in the discussion; 1) online, through Culture Talks; 2) in-person, at local town hall meetings; 3) by leaving a comment online (the link can be found below the Discussion Paper); and 4) by submitting your comments in writing—via fax, email, post, or by visiting Ontario's Environmental Registry. Page 17 of the Discussion Paper cites all the necessary contact information required for sending written submissions. A complete list of the remaining town hall meetings is included below.
