The Chief Administrative Officer and the Commissioner of Development and Infrastructure Services indicated the purpose of this meeting was to obtain feedback from Members of Council on the proposed draft budget. They introduced the Director of Financial Services/Treasurer and the Director of Corporate Communications. The Director of Financial Services addressed those present with a PowerPoint Presentation highlighting details of the Preliminary 2017 Draft Budget including Council's strategic priorities.

The Director of Corporate Communications provided an overview of community engagement activities that included the 2017 budget game and various advertising techniques related to budget topics.

Members of Council queried staff with requests for explanation of aspects of the budget document including extraordinary costs, stormwater rates, tax rates, traffic mitigation measures, sidewalk clearing, possible revenue generating opportunities, enhancements and service levels, targets and sustainability.
