- a) Councillor Kerwin advised that the Historical Society meeting scheduled for January 16, 2013 beginning at 7:00 p.m. at the Community Centre will feature Mr. Tom Taylor as a special guest who will address historical questions from the Committee.
- b) Councillor Twinney requested a placeholder on the February 4, 2013 Committee of the Whole agenda for discussion related to the Glenway lands.
- c) Regional Councillor Taylor suggested that if a placeholder for discussion takes place at the February 4, 2013 Committee of the Whole meeting related to Glenway lands, that also a Closed Session placeholder be added.

- h) Councillor Sponga requested staff investigate the need for an accessible parking space on Main Street between Ontario Street and Davis Drive and report back by April 2013.
- i) Councillor Di Muccio requested that the Economic Development Officer provide her with information as soon as possible regarding the Financial Incentives Program Application process.
- j) Councillor Di Muccio provided a notice of motion for the next scheduled Committee of the Whole meeting regarding a request to the Province of Ontario to cover all the appeal costs associated with the Town's growth plan exercises.
