Athol Hart provided an update on the status of two plaques to be installed in the downtown area related to the Riverwalk Commons trail and the remnants of the old rail by Old Town Hall.

#### 6. Sub Committee Reports

a. Architecture, Recreation, Culture, Heritage (ARCH) Committee

Athol Hart provided an update on the planning of the Rebel Heartland event.

b. Elman W. Campbell Museum Board

Billie Locke provided an update on the item proposed at the March Heritage Newmarket meeting regarding a plaque which would mark the millstone at the Museum. She reported the Museum Board is supportive of the plaque. She also provided an update on the Museum sign which is now going through the procurement process. She expressed concern that the sign replacement has been delayed for a long period of time and that the procurement process may delay the replacement further.

c. Lower Main Street South Heritage Conservation District Advisory Group

Athol Hart provided an update on the King George Hotel building which will be renovated for the creation of a new restaurant. He advised that the Advisory Group is largely supportive of the changes to the building and will ask for two additional changes to be more in keeping with the original Georgian style. The first change is the replacement of the plate glass window with two windows, in the original style of the building. The second change is a replacement of the main door on the hotel building so that the original entrance is prominently featured. Athol Hart advised that as these changes are not required but recommended, it would be appropriate for the Heritage Committee to offer financial assistance from the heritage fund.

#### NOTICE OF THE PASSING OF A ZONING BYLAW BY TOWN OF NEWMARKET

**TAKE NOTICE** that the Council of the Town of Newmarket passed **By-Law Number 2018-12** on the **26**<sup>th</sup> **day of March, 2018**, under Section 34 of the Planning Act, R.S.O. 1990, c. P. 13, as amended.

**AND TAKE NOTICE THAT** any person or public body may appeal to the Ontario Municipal Board in respect to the By-law by filing with the Clerk of the Corporation of the Town of Newmarket no later than **4:30 p.m. on the 17th day of April, 2018** a notice of appeal setting out the objection to the By-Law and the reasons for the appeal, accompanied by the prescribed appeal fee(s), made payable to the Minister of Finance in the amount of \$125.00. If you wish to appeal to the OMB, a copy of an appeal form is available from the OMB website at www.omb.gov.on.ca. In addition, to the fees listed above, pursuant to By-law No. 2012-81, a processing fee of \$150.00 per Ontario Municipal Board appeal, payable to the Town of Newmarket is required to be paid at the time of filing a Notice of Appeal

An explanation of the purpose and effect of the bylaw, describing the lands to which the bylaw applies, and a location map showing the location of the lands to which the bylaw applies (or alternatively, an explanation as to why a location map is not provided) are attached. The complete bylaw is available for inspection in the Town Clerk's office during regular office hours.


Only individuals, corporations and public bodies may appeal a zoning bylaw to the Ontario Municipal Board. A notice of appeal may not be filed by an unincorporated association or group. However, a notice of appeal may be filed in the name of an individual who is a member of the association or the group on its behalf.

No person or public body shall be added as a party to the hearing of the appeal unless, before the by-law was passed, the person or public body made oral submissions at a public meeting or written submissions to the council or, in the option of the Ontario Municipal Board, there are reasonable grounds to add the person or public body as a party.

The subject lands are also the subject of an Official Plan Amendment (D9 NP17 19)

By-law 2018-12 prohibits the storage of hazardous materials


By-Law 2018-12 provides for specific lot, siting and building specifications
