Deputy Mayor & Regional Councillor Taylor advised that he had recently attended a roundtable discussion on cannabis issues with Newmarket-Aurora MPP Christine Elliott.

Mayor Van Bynen advised that cannabis issues had also been discussed at the recent conference held by the Association of Municipalities of

Ontario (AMO) and that these presentations are available on the Association's website.

10.2 Vandalism and Safety Issues

Councillor Twinney advised that she had received concerns from residents related to vandalism and safety on walkways. She inquired if staff had considered installing cameras in problem areas. P. Noehammer advised that staff are working with York Region Police and that in some instances cameras would be used. He advised that staff would explore further the use of cameras or other measures.

Councillor Bisanz advised that some walkways have missing or broken lights and that replacing these lights could help with these safety issues. P. Noehammer advised that staff would look at replacing these lights.

10.3 Status of 330 Premier Place

Councillor Kerwin inquired into the status of the property at 330 Premier Place. E. Armchuk advised that rehabilitation work had taken place and that the majority of the works were completed.

10.4 Demolition of Scout Hall

Councillor Kerwin inquired as to the status of the demolition of the Scout Hall and the future for the property. P. Noehammer advised that the demolition of the building is imminent. I. McDougall advised that long-term plans may incorporate the property into the larger surrounding property for recreation uses.

11. Closed Session

Mayor Van Bynen advised that there was no requirement for a Closed Session.

12. Public Hearing Matter (7:00 PM)

The Clerk welcomed the public to the Committee of the Whole meeting. She advised that the Planning Act requires the Town to hold at least one public meeting on any proposed Official Plan Amendment or Zoning By-law Amendment.

The Clerk advised that the purpose of the public meeting is to hear from anyone who has an interest in the following two applications:

The first application is for the New Zoning By-law for the Urban Centres. The effect of this project is to enact new zoning within the Urban Centres in order to implement the Urban Centres Secondary Plan.

The second application is for an amendment to Zoning By-law 2010-40. The effect of this zoning by-law amendment is to address technical errors, improve clarity, respond to changing development trends, amend permissions related to specific properties, and ensure consistency between Zoning By-law 2010-40 and the new Urban Centres Zoning By-law

She further advised that the Committee of the Whole would not be making a decision regarding the proposed application, but will refer all written and verbal comments to Planning Staff to consider and return with a report to a future Committee of the Whole or Council meeting.

The Clerk advised that if anyone present wished to be notified of any subsequent meetings regarding this matter, they should complete the further request form using the iPad set up for this purpose.

The Clerk noted that in accordance with the Planning Act, the Local Planning Appeal Tribunal may dismiss an appeal to the Tribunal, without holding a hearing, if the appellant failed to make either oral submissions at the public meeting or provide written submissions to Council prior to adoption of the application.

The Clerk thanked residents for their participation and interest in the meeting.

12.1 Urban Centres Zoning By-law

lan Graham of R.E. Millward and Associates provided a presentation on the Urban Centres Zoning By-law. The presentation gave an overview of the Urban Centres Zoning by-law including the associated policies and the format of the by-law.

12.2 Zoning By-law 2010-40

T. Horton, Planner provided a presentation regarding the Zoning By-law, including an overview of the current by-law and the history of its amendments. He further provided an overview of the categories which included in the revised by-law and the next steps.

By-law 2018-45

A By-law to Adopt Fees and Charges for Services or Activities Provided by the Town of Newmarket (Legislative Services – Licensing Fees)

Whereas the Municipal Act, 2001, S.O. 2001, c.25 authorizes a municipality to enact by-laws imposing fees and charges for services or activities provided or done by or on behalf of it; and,

Whereas Council enacted By-law 2017-71 being a By-law to adopt fees and charges for services or activities provided by the Town of Newmarket (Legislative Services – Licensing Fees);

Whereas it is deemed necessary to enact a new by-law setting out the Licensing Fees and Charges for Legislative Services and to repeal By-law 2017-71.

Therefore be it enacted by the Municipal Council of the Corporation of the Town of Newmarket as follows:

- 1. That the attached schedule form part of this by-law and this by-law be known as the Fees and Charges By-law for the (Legislative Services Licensing Fees); and,
- 2. That should any section of this by-law be deemed invalid by a court of competent jurisdiction, such section shall be construed as being served here from and the remainder of the by-law shall continue in full force and effect; and,
- 3. That notwithstanding fees and charges prescribed in other legislation this by-law supersedes all other fees and charges for Legislative Services Licensing Fees previously established by the Town of Newmarket for the services identified in this by-law; and,
- 4. That this by-law shall come into full force and effect on January 1, 2019 at which time By-law 2017-71 be repealed.

A By-law To Exempt Certain Lands From The Part Lot Control Provisions Of The Planning Act.

(Sundial Homes (Davis) Limited) Blocks 86, 93, 94, 95, 96, 97, 98 and 100 Registered Plan 65M-4565.

Whereas it is deemed advisable to exempt certain lands from the provisions of Section 50(5) of the Planning Act, R.S.O. 1990, c.P.13;

And whereas the land use to be accommodated by the exemption, the parcel to be created, and any remaining parcel, are in conformity with the governing Official Plan and are permitted and in conformity with the zoning By-law in effect for the area in question;

And Whereas Plan 65M-4565 was registered on June 28, 2017 and the construction of the units in Blocks 86, 93, 94, 95, 96, 97, 98 and 100 have now advanced to a point where it is appropriate to enact the required By-law;

Therefore be it enacted by the Council of the Corporation of the Town of Newmarket as follows:

- 1. That the provisions of Section 50(5) of the Planning Act, R.S.O. 1990, c.P. 13 do not apply to the lands described as Blocks 86, 93, 94, 95, 96, 97, 98 and 100, Registered Plan 65M-4565, further described as Parts 1 through 20 inclusive, on Plan 65R-37952; Parts 1 through 24 inclusive, on Plan 65R-37953, Parts 1 through 25 inclusive, on Plan 65R-37990, Parts 1 through 36 inclusive, on Plan 65R-37991, Parts 1 through 14 on Plan 65R-37992 Town of Newmarket, Regional Municipality of York.
- 2. And that the Municipal Solicitor or designate be authorized and directed to electronically sign and register this By-law on title.
- 3. And that this By-law will lapse after a period of 2 years from the date of enactment.



By-law 2018-47

A By-law to confirm the proceedings of a meeting of Council – September 10, 2018

Whereas s. 5(1) of the Municipal Act, 2001, S.O. 2001, c. 25 provides that the powers of a municipal corporation shall be exercised by its Council; and,

Whereas s. 5(3) of the Municipal Act, 2001, S.O. 2001, c. 25 provides that a municipal power, including a municipality's capacity, rights, powers and privileges, shall be exercised by by-law unless the municipality is specifically authorized to do otherwise; and,

Whereas the Council of the Town of Newmarket deems it advisable to pass such a by-law;

Therefore be it enacted by the Council of the Corporation of the Town of Newmarket as follows:

- That subject to Section 3 of this by-law, every decision of Council, as evidenced by resolution or motion, taken at the meeting at which this by-law is passed, shall have the same force and effect as if each and every one of them had been the subject matter of a separate by-law duly enacted;
- 2. And that the execution and delivery of all such documents as are required to give effect to the decisions taken at the meeting at which this by-law is passed and the resolutions passed at that meeting are hereby authorized;
- And that nothing in this by-law has the effect of giving to any decision or resolution the status of a by-law where any legal prerequisite to the enactment of a specific by-law has not been satisfied;
- 4. And that any member of Council who disclosed a pecuniary interest at the meeting at which this by-law is passed shall be deemed to have disclosed that interest in this confirmatory by-law as it relates to the item in which the pecuniary interest was disclosed.
