3. E-Waste Challenge - Suggestions and Use of New Sponsors.

J. Birchall presented advertising materials, including a proposed flyer, poster and banner for the E-Waste Challenge. The event will take place on Saturday, September 27, 2014 from 9:00 a.m. to 3:00 p.m. at Upper Canada Mall. Tim Horton's will be sponsoring the event. Discussion ensued regarding the advertising materials.

4. Trail Map Update

J. Parsons advised that the Town's Recreation and Culture Department has agreed to pay the difference so that 8,500 trail maps can be ordered at an additional cost of approximately \$1,900.00. D. Laxton and J. Parsons have been working with Town staff to finalize the print version of the trail map. Joanna Parsons to follow up with the Town on the status of the finalized trail map.

5. Ian Gray Award Review and Action Items.

J. Birchall provided an overview of the lan Gray Award process. He suggested that the process is overly complicated and could be simplified and requested that Committee members review any opportunities to amend the process. Discussion ensued streamlining the award, outreach to schools and identification of award deliverables. The Committee determined that a working, efficient and results driven process needs to be determined. D. Jagger advised that the Community Garage Sale will occur on Saturday, May 31, 2014 from 8:00 a.m. to 12:00 p.m. at the northwest corner of Yonge Street and Eagle Street in the parking lot and provided a status update on the event planning. There are eight registrants to date and the Town has committed to providing cones and barricades but is unable to deliver to the site. D. Laxton is in discussions with the Town in order to obtain a sign permit and D. Jagger will post the signs on Monday, May 26, 2014. The draft sign has not yet been approved by Communications. D. Jagger advised that volunteers are still required to assist on the event day.

IAN GRAY MEMORIAL ENVIRONMENTAL AWARDS 2012-2013

The Ian Gray Memorial Environmental awards programme is composed of two parts.

The first part is an award of up to three grants of up to \$500 each to any public, separate or private school in Newmarket from K-Grade 12 who submits an application each fall as outlined below for a sustainable environmental project that creates environmental awareness and environmentally friendly initiatives and helps make for a more sustainable environmentally friendly town. The award will be granted in December by NEAC.

The second part of the award is the presentation of the Ian Gray Environmental Award of the year to be presented in spring before the end of school. Entrants in this award do not have to be the recipient of one of the grants above but will be required to document their project, the benefits, and how it improved the environment in Newmarket.

Entrants will also be asked to demonstrate their project at a public session devoted to these projects in order that the groups receive appropriate recognition and the community at large can learn from the competing projects.

From these submissions, a project will be awarded the Ian Gray Environmental Award of 2011-2012 and a presentation will be made by Newmarket Council to the winning group at a formal council meeting in June, both of the award and a \$500 cheque.

Part A: Environmental Grants for Students K-12

- The Ian Gray Environmental Grant is a way to promote environmental issues, promote environmental sustainability, and increase awareness of environmental challenges and how we can best approach these issues in Newmarket. We believe the students are the best agent for making change in our environment.
- Eligible for up to three grants of up to \$500 for Environmental projects that target current environmental issues in Newmarket, enhance environmental awareness and help lead to a more sustainable environment in the community
- To be considered for a grant your proposed environmental initiative must address a minimum of one of the criteria below:
 - Cleaner Air/Reducing Greenhouse gas emissions
 - Water conservation
 - Managing waste through recycling/composting/reduction of waste
 - Sustainable Energy use
 - Biodiversity Improvements wetlands/groundwater/rivers
 - Application: Notices will be sent to schools and a notice will be posted on the Town page of the Newmarket Era. The application form will be available on the Town web site. *Submissions are to be made by November 23, 2012*.
 - Grants will be announced in early December and paid before year end
 - We encourage groups that have access to adequate funding and do not require a grant to advise NEAC (<u>NEAC@newmarket.ca</u>) of the project you are undertaking in order that we may help promote your good work

HOW TO ENTER:

Complete the attached application form and deliver to the Town of Newmarket Municipal office on or before November 23, 2012. Send to the Chair, NEAC, c/o Planning Department

ELIGIBILITY:

The Award is open to all students, student groups attending school in Newmarket.

GRANT SELECTION CRITERIA

Entries will be judged according to the following general criteria:

- Project exemplifies the Environmental objectives of cleaner water, cleaner air, reduced greenhouse emissions, or reduction in energy use
- Project addresses an overwhelming need at the local level with quantifiable community benefits and results are demonstrable
- Project exemplifies long term planning with respect to use of the Grant's funding and/or environmental and community sustainability
- Project is unique, innovative and will be used to show others how to reduce impact on the environment
- The grant is required to attain the project results and how the money is used in the project will be evident

- 1. Each school can enter one project per year. No fee applies.
- 2. Supplementary information must not exceed one page

 - 2-5 photographs of the project or site of the project. Artists' rendering can be submitted in place of photographs where they illustrate a design or construction element that cannot be captured otherwise.
