### RECOMMENDATIONS

### **PURPOSE**


The purpose of this report is to recommend amendments to 2015 fees and charges for Legislative Services. As a result of a clerical error included in By-law 2014-58, Schedule "F" passed by Council on December 8, 2014, the incorrect fees were authorized, with regard to Municipal Information – Liquor Licence, Property Standards Appeal fee, and Ground Signs. The following fees should have been recommended for 2015:
