

## **Corporation of the Town of Newmarket**

## By-law 2020-22

A By-law to amend various By-laws in relation to the Administrative Monetary Penalty System in the Town of Newmarket.

Whereas the Municipal Act, 2001 and Ontario Regulation 333/07 authorizes a municipality to require a Person to pay an Administrative Penalty for a contravention of any By-law respecting the parking, standing or stopping of vehicles; and,

Whereas the Municipal Act, 2001 authorizes a municipality to pass by-laws imposing fees or charges for services or activities provided or done by or on behalf of it; and,

Whereas Council enacted By-law 2019-62 to implement an Administrative Monetary Penalty System in the Town of Newmarket; and,

Whereas it is deemed necessary to amend the Schedule A of By-law 2019-62 as it relates to the Designated By-law Provisions; and,

Whereas it is deemed necessary to amend By-laws 2002-151, 2008-79, 2013-13, 2015-18, 2016-33, 2016-53, 2017-62, 2017-63, 2017-73, and 2017-19 as it relates to the inclusion of enforcement through the Administrative Monetary Penalty System in the Town of Newmarket.

Therefore be it enacted by the Municipal Council of the Corporation of the Town of Newmarket as follows:

- 1) That Schedule A to the By-law 2019-62 be repealed and replaced by the attached Schedule A; and,
- 2) That the following paragraphs be added to the By-laws listed below at the end of the identified sections:
  - i. Every Person who contravenes any provision of this By-law is liable to the fines and administrative fees set out under the Administrative Monetary Penalty System By-law 2019-62, as amended, and each day shall constitute a new and separate offence.
  - ii. Every Person who is in contravention of the provisions of this By-law may request a review of the matter in accordance with the Administrative Monetary Penalty System By-law 2019-62, as amended.
