## Have you seen this sign?

The Town of Newmarket wants YOUR opinion on the Application to develop the **Police Club Lands** (600 Stonehaven Ave.) submitted by Marianneville Stonehaven Ltd. of Toronto, ON.

### The Application provides for the following:

- 1. Change the designation in the Town's Official Plan from PARKS and OPEN SPACE to EMERGING RESIDENTIAL.
- 2. Re-zone the property from OPEN SPACE (OS-2) to RESIDENTIAL (R1-E, R1-F and R4-R)
- 3. Demolish the Police Club building and remove all playing fields.
- 4. Change the flood plain, build on the watershed and implement alternative drainage methods.
- 5. Remove 291 of the 308 large trees on the property, as well as most of the medium and small trees.
- 6. Build 142 Townhouses and 60 Single Detached Houses on lot widths as small as 5.5 metres.
- 7. Route the traffic from all 202 dwellings to flow out to Stonehaven Avenue.
- 8. Build an almost **continuous wall of townhouses** along Stonehaven Avenue all the way to Bayview Avenue, in such as manner that the views and green space will no longer be visible from Stonehaven Avenue.
- 9. Build within an ecologically sensitive area that has not yet been adequately researched.
