## Memorandum Supplementary Information – 2022 Capital Program

## **PURPOSE**

To provide supplementary information on the 2022 Capital Program following discussions at the December 6 Committee of the Whole meeting (CoW).

## **BACKGROUND**

Staff tabled the report and presentation on "2022 Draft Operating and Capital Budgets" at the December 6 CoW.

Below outlines Staff responses to questions raised at the meeting that required further clarification:

 Listing of projects included in the capital request "Parkettes and Sports Pad – scope, public engagement, design" with budget of \$50,000

Response: Refer to Appendix A for detailed listing of projects included in the request.

2. Identify adjustments to 2022 capital projects that made up adjustments totalling \$4,084,000

Response: Refer to Appendix B for detailed listing of 2022 capital projects that were adjusted in order to accommodate inclusion of additional projects while maintaining the capacity threshold at \$20,000,000 for the standard program.

3. Given the condition assessment on Bridges & Culverts from the Asset Management Executive Summary, is there any risk to reallocating the 2022 Bridges & Culverts requests to 2023?

Response: 2022 Bridges & Culverts request is for reconstruction of Queen St. Bridge over the railway. Staff are currently working collaboratively with Rogers, Bell and Metrolinx to reconstruct the bridge as soon as possible. The original project timeline is to complete the Rogers/Bell utility relocation in 2021 and begin bridge construction in 2022. Due to delays in Rogers and Bell's work to reallocate their infrastructure, it is anticipated that utility relocation will be completed in 2022 and bridge construction will commence in 2023.
