Relevant By-law Sections

Business Licensing Bylaw 2020-31

Item line no. 49 - Operate without a business licence

Proposed Increase in Penalty Amounts: from \$600/\$900/\$1,350 to \$1,000/\$2,000/\$3,000

Related By-law Section:

- 3. General Regulations
 - (1) A Person must not carry on any Business unless that Person holds a valid and subsisting Business Licence issued to that Person for that Business within the Town.

Considerations: Increased fines under this section would apply all businesses.

Business Licensing Bylaw 2020-31

Item line no. 50 - Failure to comply with legislation

Proposed Increase in Penalty Amounts: from \$600/\$900/\$1,350 to \$1,000/\$2,000/\$3,000

Related By-law Section:

- 3. General Regulations
 - (2) Every Business shall comply with all federal, provincial, and municipal bylaws and regulations applicable to the Business and the Business Premises.

Business Licensing Bylaw 2020-31 Item line no. 58 – *Operate business while licence is suspended*

Related By-law Section:

- 7. Suspension, Cancellation, and Refusal
 - (9) No Person shall conduct any Business pursuant to their Business Licence during a period of suspension of that Business Licence.

Business Licensing Bylaw 2020-31 Item line no. 59 – Advertise business while licence is suspended

Related By-law Section:

- 7. Suspension, Cancellation, and Refusal
 - (10) No Person shall Market a Business during a period of suspension of that Business' Licence.

Business Licensing Bylaw 2020-31 Item line no. 60 – *Remove posted notice of suspension*

Related By-law Section:

- 7. Suspension, Cancellation, and Refusal
 - (12) A posted notice of suspension, cancellation, or refusal of a Business Licence shall not be removed until the Manager has approved the issuance of a valid Business Licence.

Business Licensing Bylaw 2020-31 Item line no. 61 – *Remove posted notice of no business licence*

Related By-law Section:

- 7. Suspension, Cancellation, and Refusal
 - (14) A posted notice of operating without a Business Licence shall not be removed until the Manager has approved the issuance of a valid Business Licence.

Business Licensing Bylaw 2020-31

Item line no. 108 - Permit live music contrary to bylaw

Proposed Increase in Penalty Amounts: from \$200/\$300/\$450 to \$600/\$900/\$1,350

Related By-law Section:

- 8.5 Commercial Rooftop Patio's
 - (3) No Live Music shall be permitted on any Commercial Rooftop Patio at any time.

Considerations: This section only applies to rooftop patios.

Noise Bylaw 2017-76

Item line no. 281 – *Make, cause or permit the emission of noise likely to disturb* Proposed Increase in Penalty Amounts: from \$200/\$300/\$450 to \$600/\$900/\$1,350

Related By-law Section:

3.1 No Person shall make, cause or permit the emission of Noise, which Noise is audible at the Point Of Reception which is likely to disturb the quiet, peace, rest, enjoyment, comfort or convenience of the Inhabitants of the Town

Considerations: Residential property related noise concerns, and lesser business noise related concerns will be subject to the same increase in penalty amounts.

Noise Bylaw 2017-76

Item line no. 292 - Make or permit noise during prohibited time

Proposed Increase in Penalty Amounts: from \$200/\$300/\$450 to \$600/\$900/\$1,350

Related By-law Section:

4.1 No Person shall make or permit the emission of Sound resulting from any act listed in the Schedule A if clearly audible at a Point Of Reception located in a prescribed area of the municipality within a prohibited time shown for such an area.

Considerations: The portion of Schedule A that applies to section only applies to yelling, shouting, hooting, whistling or singing within 100 metres of a hospital, retirement home, nursing home, senior citizens residence or other establishments of similar use. Additionally, this change would affect every other type of noise violation indicated in Schedule A of the Noise By-law as they would be subject to the same increase in penalty amounts.
