#### 4.1 CYFS Second Quarter Results 2022

Anita Gibson, Senior Financial Analyst, Town of Newmarket provided a presentation regarding the Central York Fire Services Second Quarter Results 2022 which provided an update on Central York Fire Services operating and capital finances.

Members of Committee inquired about wellness program finances. Deputy Chief Volpe advised that savings resulting from the program delay would be transferred, that there will be information sessions for staff, and that there will also be in-house training, peer support fitness instructors, and tablets purchased.

Councillor Bisanz inquired about how inflationary pressures will impact expenditures. Deputy Chief Inglis responded that there has been a gradual increase to cost pressures starting in the second quarter and staff anticipate that inflationary pressures may level out in the third and fourth quarters.

# 8.1 Junior Firefighter Day
