4.1 The New World of Land Use Planning: Understanding the Impacts of Recent Changes

The Director, Planning and Building provided an introduction. Kim Mullin, Wood Bull LLP, provided a presentation that outlined changes to the Planning Act, Ontario Heritage Act, Conservation Authorities Act, and the Development Charges Act.

Members of Council queried the presenter regarding internal approval processes, inclusionary zoning, affordable housing, resulting changes to the Town's internal application processes, and changes to official plan approvals.
