

Corporation of the Town of Newmarket

By-law 2023-28

A By-law to authorize the appointment of Building Officials for the purpose of enforcing the [Ontario] Building Code Act and regulations thereunder.

Whereas Section 3(2) of the Building Code Act, S.O. 1992, C.23, as amended, states that the Council of a municipality shall appoint a Chief Building Official and such Inspectors Building Officials as are necessary for the enforcement of this Act within the Town of Newmarket;

Whereas Section 1.1(6) of the Building Code Act, S.O. 1992, C.23, as amended, states that the role of the Chief Building Official is to co-ordinate, establish operational policies, oversee, exercise powers and perform duties in accordance with the standards and qualifications established, for the enforcement of this Act and the [Ontario] Building Code;

Whereas Section 22(2) of the Building Code Act, S.O. 1992, C.23, as amended, states that the Chief Building Official may exercise any powers and perform any duties of a Building Inspector [Official], in accordance with the standards and qualifications established, for the enforcement of this Act and the [Ontario] Building Code;

Whereas Section 1.1(7) of the Building Code Act, S.O. 1992, C.23, as amended, states that the role of the Building Inspector [Official] is to review plans, inspect construction, exercise powers and perform duties in accordance with the standards and qualifications established, for the enforcement of this Act and the [Ontario] Building Code;

Therefore be it enacted by the Council of the Corporation of the Town of Newmarket as follows:

- 1. Person listed on Schedule "A" to this by- law is hereby appointed by Council as Chief Building Official for the Town of Newmarket.
- 2. Person(s) listed on Schedule "B" to this by-law are hereby appointed by Council as Acting Chief Building Official in the absence or unavailability of the Chief Building Official.
- 3. Person(s) listed on Schedule "C" to this by-law are hereby appointed by Council as Inspectors Building Officials for the Town of Newmarket.
- 4. The Clerk of the Town of Newmarket, under Section 3(8) of the [Ontario] Building Code Act, shall issue a certificate of appointment or authorization to the Chief Building Official and to each Inspector [Building Official] appointed by the Council of the Town of Newmarket.
- 5. This Building Officials Appointment By-law 2023-28 shall come into full force and effect as of May 15th, 2023.
- 6. Appointment By-law 2021-39 is hereby repealed on the date replacement By-law 2023-28 comes in effect.
