



# Corporation of the Town of Newmarket

## By-law 2024-XX

A By-law to amend By-law 2019-63 being a By-law to regulate parking, standing, and stopping of Motor Vehicles within the Town of Newmarket and to amend By-law 2024-16 being a By-law to operate the Administrative Monetary Penalty System in the Town of Newmarket.

WHEREAS Section 102 of the Municipal Act authorizes a municipal council to pass a by-law and to make regulations for the health, safety, morality and welfare of the inhabitants of the municipality in matters not specifically provided for in the Act;

AND WHEREAS Section 11 of the Municipal Act authorizes a municipal council to pass by-laws respecting to Highways, including parking and traffic on highways;

AND WHEREAS Section Whereas the Municipal Act, 2001 and Ontario Regulation 333/07 authorizes a municipality to require a Person to pay an Administrative Penalty for a contravention of any By-law respecting the parking, standing or stopping of vehicles; and,

AND WHEREAS the Municipal Act, 2001 authorizes a municipality to pass by-laws imposing fees or charges for services or activities provided or done by or on behalf of it; and,

AND WHEREAS Council enacted By-law 2024-16 to implement an Administrative Monetary Penalty System in the Town of Newmarket; and,

AND WHEREAS it is deemed necessary to amend the By-law 2019-62 to establish a Special Enforcement Zone to promote compliance.

AND WHEREAS it is deemed necessary to amend By-law 2024-16 in order to implement administrative monetary penalties for violations found within the Special Enforcement Zone.

Therefore be it enacted by the Municipal Council of the Corporation of the Town of Newmarket as follows:

1. That Section 7 of By-law 2019-63 be amended to add the following section subsection:

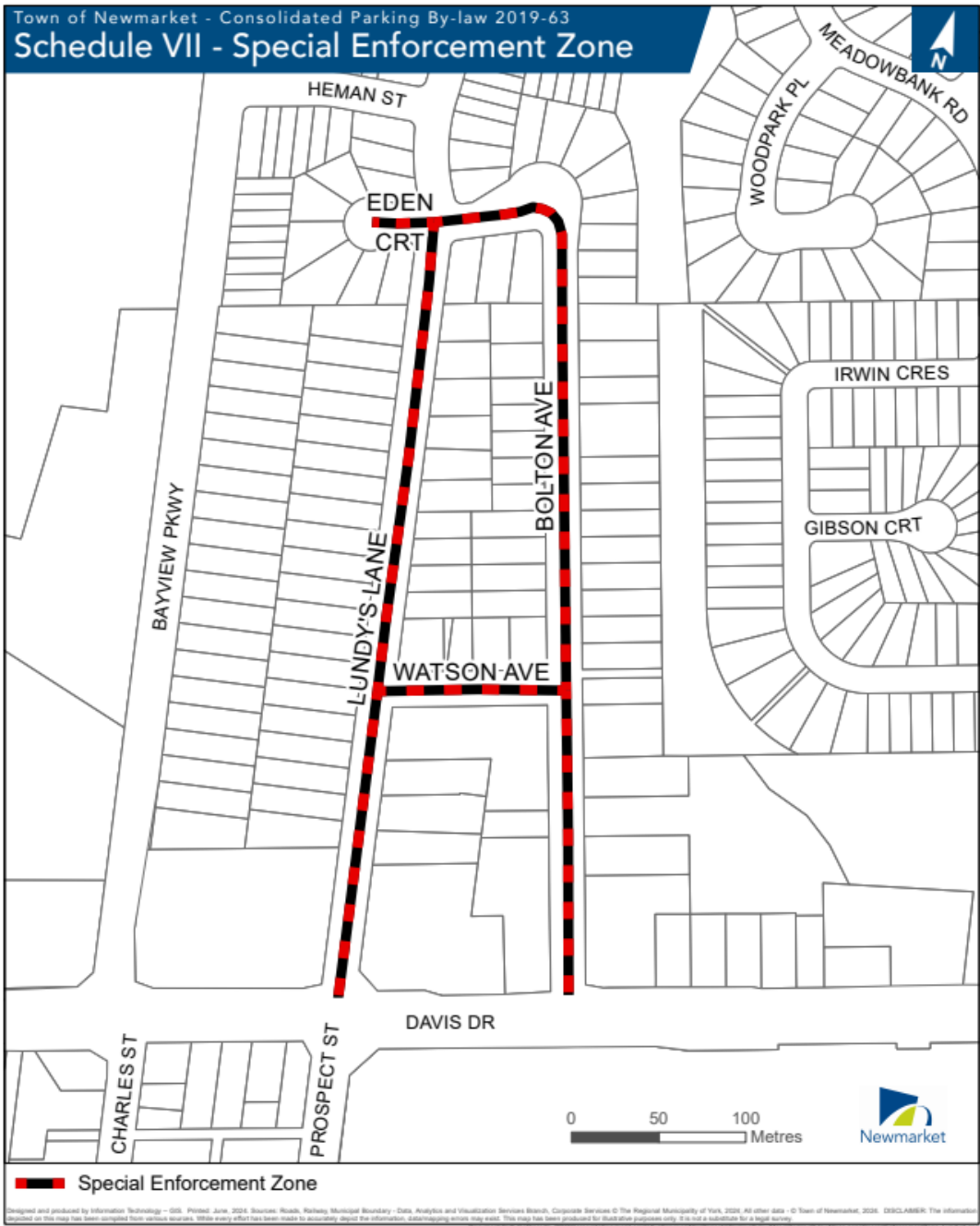
(6) Within a **Special Enforcement Zone**, no person shall:

- a) Park contrary to no parking sign
- b) Stop contrary to no stopping sign
- c) Park within 3 meters of a hydrant
- d) Park within 0.6m of a driveway
- e) Park Commercial Vehicle on roadway unless it is, at that Time, being used to make a delivery or to provide service
- f) Park on Private Property without consent of the Owner or Occupant of the property

2. That Section 2 of By-law 2019-63 be amended to add the following definition:

“**Special Enforcement Zone**” means an area, approved by Council and identified in Schedule 7 of this By-law, that requires higher monetary penalties to encourage compliance with parking regulations.

3. That the following Schedule VII be added to By-law 2019-63 to assist in defining the “Special Enforcement Zone”:



4. That Schedule A of By-law 2024-16 be amended to add the following:
