Hi Umar,

Please see my comments below for 932 Isaac Phillips Way.

- The Tree Report Form has been filled out incorrectly. There is a street tree present and would be impacted by the driveway extension.
- The street tree is part of the engineering approved drawings and is a requirement.
- Alterations to tree plantings in unassumed subdivisions would create issues for developers during the assumption process and would result in additional fees to be paid by the developer.
- There is no space to shift the Street Tree to accommodate the driveway while still
  meeting the required tree offset of 1.5m from hard surfaces.
- The property owner had called customer service in September 2023, a CRM ticket
  was created noting that the property owner wanted to request no boulevard tree be
  planted at this address as he felt the area would be too crowded and he won't be able
  to see who is parking there.
- Due to space constraints of the subdivision, there are minimal areas where street trees can be planted.
- It is not recommended that this MV be permitted due to the impact on the Street Tree.
