Access Activations: Advancing Cultural Accessibility in Ontario's Public Sector with <u>Eliza Chandler</u>, School of Disability Studies, Toronto Metropolitan University



Session Description: Ontario has committed to increasing accessibility for disabled people through a combination of the Accessibility for Ontarians with Disabilities Act (AODA), which motivates public institutions to identify, remove, and prevent barriers in their built environments, and dedicating training and funding to facilitate legislative compliance. Alongside these commitments, we have a roster of skilled professionals who provide accessibility services, such as sign language interpreters and audio describers (who provide spoken narration of visual elements). While this legislation and skilled labour force have the potential for improving access within the public sector, public institutions typically lack the comprehensive accessibility plans that are required to initiate systemic changes. Such changes are required in order to shift cultural practices and achieve true inclusivity for Deaf, disabled, mad, and neurodivergent communities. In this presentation, I will demonstrate how the public sector must work with disabled people to develop and implement accessibility plans specific to their organization in order to advance accessibility in Ontario to support organizations in meeting their full access potential, these plans will combine universal design standards for built environments and cultural accessibility. "Cultural accessibility" refers to flexible practices created by disabled people to meet the needs of diverse publics. An increasingly popular cultural accessibility practice is the provision of access guides; a plain language resource that provides details about specific sensory advisories, content information, and accessibility features that are disseminated to audiences in advance of an event. Throughout this talk, I will introduce innovative cultural accessibility practices that can be adopted within the public sector to increase accessibility by centering disabled people and transforming culture.
