#### 5. Items

#### 5.1 MV-2024-041- 724 ARTHUR STREET (WARD 2)

The Chair stated item MV-2024-041 has a rrecommendation from the Town Planning Staff to defer to a future meeting.

The applicant is proposing the construction of an accessory structure (to legalize an existing shed). The following relief is requested from Zoning By-law 2010-40, as amended:

1. Relief from Section 4.2 Encroachments into Required Yards to permit a shed (2.9m in height) setback to a side property line of 0.2m whereas the By-law requires sheds (2.9m in height) to be at minimum setback to a side property line of 2.4m.

Brian Shickluna, Owner, not present at the meeting. The Owner provided an email and is aware and accepts the deferral and will work with staff to re-submit a revised proposal for the December 18<sup>th</sup>, 2024 meeting.

The Chair mentioned that any revised plans will be available for Committee and the public to review.
