Application for Site Plan Approval to permit an 8 storey Administrative Centre Annex Building with a gross floor area of 37,628.6 m<sup>2</sup> together with 2 levels of underground parking and a pedestrian bridge of 137.76 m<sup>2</sup> connecting the proposed annex building to the main administrative building at 17250 Yonge Street on the subject lands.

**The Site Plan Review Committee recommends:**
