Members queried Bill White and David Ecclestone on Ontario Building Code requirements, emergency exits, way-finding to barrier-free locations, use of 1:15 slope of ramp versus 1:12, width of the elevators, door widths, use of automatic door operators, and engaging with Central York Fire Services for consultation on barrier-free emergency exits.
